Licences on our other machines (UNIX) run indefinitely - if one chooses not to upgrade (ie. pay) one at least keeps the old version, no RSI support necessary. IDL5.5 is the last release for Linux Alpha (AFAIK). So I can't upgrade, so I won't be paying for upgrades... except I will have to, otherwise RSI won't give me support to generate new licences.
